
HOW TO REGISTER

The following registration process must be followed in order to take the above mandated Job and Family Services Trainings. **NOTE: Registration will NOT be taken in person or by phone.**

Registering for a PRIVATE AFC class through The Ohio Professional Registry.

The Ohio Professional Development Registry, or OPR for short, is a tool for you to track your professional development (create your own career ladder) and to register for trainings offered by Action for Children (AFC) and other agencies, including those that meet Job and Family Service requirements.

Go to <u>www.registry.occrra.org</u> and log in to your profile; or, if you are new to the Professional Development Registry, you'll need to set up your Profile in order to register for trainings. Go to: <u>www.occrra.org</u> Select "Create Profile" in upper right of page.



LOCATION: All classes will be held at Action for Children (78 Jefferson Ave., Columbus, OH 43215)

PARKING OPTIONS:

- 1. At the **meters** in front of the building (must pay with coins).
- 2. In the lot across from St. Paul AME Church (corner of Long and Jefferson) in spaces marked 44-88.
- 3. If you are attending a class on **Saturday or after 5:30pm during the week**, you may park in the lot behind the building. <u>Please note</u>: all participants attending classes in the evenings and on Saturdays must enter in the back of the building.

<u>15 MINUTE GRACE PERIOD</u>: Action for Children courses start promptly and it is recommended that participants **arrive at least 10-15 minutes prior to the start** to get signed-in. Since credit is awarded in clock-hours **those more than 15 minutes late will not be allowed to attend the course**.

<u>CHILDREN & ANIMALS</u>: Action for Children *cannot* accommodate children or animals (except service animals) during training courses. <u>Please make alternate arrangements.</u>
