Review the required verifications for PRC benefits to be submitted for quicker PRC processing.

Must have a minor a child or be currently pregnant to qualify

Must meet income guidelines

Income must be 30 days from application date

Rent/Mortgage
☐ The last 30 days of income for EVERYONE in the home.
☐ <b>W-9 form</b> - completed by the <i>landlord and/or mortgage company</i>
☐ Landlord statement (PRC) Housing Needs Assistance Form (ERA) — completed by the landlord
☐ Full lease agreement – signed and dated by tenant and landlord
☐ <b>Proof of mortgage</b> ☐ <b>1.</b> Being over <i>five</i> days overdue ☐ <b>2.</b> Statement of <i>what month(s)</i> are due
☐ Copy of any subsidized assistance agreement – if applicable
Security Deposit
☐ The last 30 days of income for EVERYONE in the home.
☐ Shelter Deposit Re-imbursement Agreement - completed by the landlord and/or mortgage company
☐ Current lease agreement – does not have to be signed
☐ Copy of any subsidized assistance agreement – completed by tenant and landlord
Temporary Housing
☐ The last 30 days of income for EVERYONE in the home.
☐ Complete a FCDJFS Temporary Housing Agreement Form
☐ <b>Hotel</b> – must complete and return a <i>W-9 form</i>
☐ <b>Ledger</b> - from the hotel where you reside
Utility Assistance
☐ The last 30 days of income for EVERYONE in the home.
☐ Copy of all utility bills you are requesting assistance with
Auto Repairs
☐ The last 30 days of income for EVERYONE in the home.
☐ Estimates – at least <i>two</i> from different companies that are registered with the Ohio Secretary of State
☐ Verifications – car insurance and copy of driver's license
☐ Car title of vehicle
☐ Payment Arrangements – Verification that arrangements were made between you and the auto repair
License/Re-Instatement
☐ The last 30 days of income for EVERYONE in the home.
